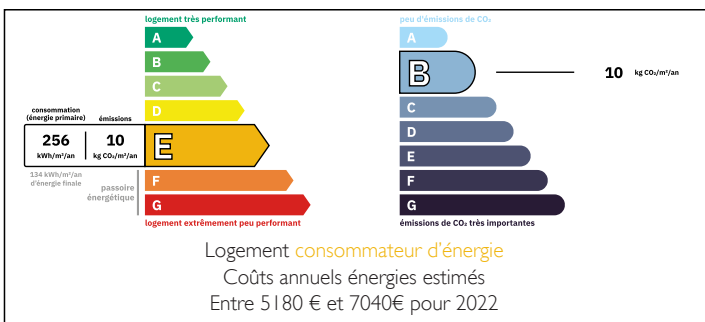

Decades of continuous investment have created a mature and efficient business, allowing buyers to take over an established operation rather than spending years developing one from the ground up.

The orchards have been professionally managed and carefully maintained to the highest organic standards. Modern irrigation systems, water reservoirs and frost protection infrastructure help ensure reliable production while supporting high-quality fruit cultivation throughout the growing season.

Supporting the business are approximately 1,150 m² of agricultural buildings, including machinery storage, workshops, operational workspaces and three refrigerated cold storage rooms with a combined capacity of approximately 300 tonnes. These facilities provide everything required for efficient harvesting, storage and day-to-day management of the business.
